9. Attendance Certificate issued by Principal
10. Student self-declaration (*Affidavit*)

The last date for online application is **28.02.2025**. All the eligible students are advised to submit their application with required documents on portal timely before the closing date.

- All eligible students, including those who had previously submitted application through the Harchhatarvratti portal should reapply on national scholarship portal (<http://scholarships.gov.in>) for academic session 2025-2026.
- Economically backwards class (EBC) students having family income up to 2.5 lacs are also eligible for applying PMS Scheme.
- DNT ( DE notified , Nomadic and semi- Nomadic tribes' students having family income up to 2.5 lacs are also eligible for applying PMS Scheme.
- Attendance Certificate Performa and Performa for student self-declaration (*Affidavit*) is attached with this notice.

- All applicants are instructed to submit two hard copies of application form along with all uploaded documents in the scholarship cell to Smt. Poonam.
